ENTRY RULES

Settimo International Short Film Festival Fifth Edition. Organized by Pro Loco Settimo Milanese with Association Semeion Teatro, Auditorium Settimo Milanese, in partnership with Fedic and under the patronage of the City of Settimo Milanese.

CALL FOR ENTRIES

- All submitted short films must not exceed 15 minutes (credits included) in terms of length (titles included) and must have been produced after January 1, 2020.
- Shorts based on any idea or concept can be admitted. Film selection will be a final decision of our jury and accepted by all. The jury can exclude any vulgar or offensive work or in contrast with this regulation. Short films must not, under penalty of exclusion, contain any advertising or promotional messages.
- A registration fee is requested to cover administrative costs. **Submission fee: 10 €.** Every author can submit at most two works. The fee charged for Production Companies is 30 euros for eight films. The entrance fee can be paid directly in FilmFreeway or Festhome or with money transfer to this IBAN IT09V0504833860000000010102 (causal Settimo Short Film Festival). The entrance fee cannot be refunded in any case.
- Only one work for every author will be selected for the screenings. Selected works will be judged by a Popular Jury and a Technical Jury. The Popular jury will be the audience at the screenings.
- **Awards**

1000 euros (in Amazon gift voucher) to the Best Short Film

300 euros (in Amazon gift voucher) to the Best Acting

300 euros (in Amazon gift voucher) to the Best Technical Realization

100 euros (in Amazon gift voucher) to People's Choice Award

The jury's decision will be irrevocable.

Deadline for short film submissions: February 12th, 2022.

The awards ceremony will take place on Saturday, 9 April 2022 at the Cinema Auditorium "Anna Marchesini", Via Achille Grandi, 12, 20019 Settimo Milanese (Milan)

Also, you must fill out the registration form on our site, send a short synopsis (maximum 10 lines) and you can send the poster of the film (recommended).

Non-Italian works have to provide English or Italian subtitles, not burned-in (.srt format)

All copies presented in this contest will not be returned and will be part of the contest archive and private video library. The organization is committed to using them exclusively in cultural events with your permission.

Every author guarantees that his work does not violate any copyright laws and is the only responsible in case of any claim.

Short films Directors or Producers of are responsible for their works and they declare with the entry to have fulfilled any obligations towards anyone who detain author rights under your state laws.

PRIVACY POLICY

Pursuant to art. 13 of Legislative Decree n. 196/2003 (hereinafter the “Privacy Code”), of article 13 of Regulation (EU) 2016/679 (hereinafter “Regulations” or “GDPR 2016/679”), we inform that:

- Data are collected to allow, directly or indirectly, the participation in the event and its development and to pursue the purposes related to festival participation and its promotion, for institutional reasons, legal obligations, and administrative purposes, and for archiving in the competition database.
- Data treatment is necessary to pursue the purposes described above; data provided will be treated both in paper and electronic form. For the latter, adequate protection measures are envisaged and adopted, as required by the legislation on the protection of personal data.
